"Market Sharing Cat" is coming to town Competition Commission launches roving tour of "Combat Market Sharing" pop-up display

The Competition Commission (Commission) will start a roving tour of its "Combat Market Sharing" pop-up display around Hong Kong from Monday, 22 January 2018 with an aim to increase community awareness of market sharing and to strengthen detection of such conduct at a district level. The initiative is an extension of the Commission's public education campaign on market sharing launched earlier.

Market sharing cartels can occur in any industry or sector. It may not be as commonly known in Hong Kong as some other forms of anticompetitive conduct such as bid-rigging but it does exist. The pop-up display features the Commission's signature cat with a giant watermelon which is a pun for "sharing the market" in Cantonese. It showcases information on different types of market sharing, tips on how to identify it and ways to report suspected cases.

The "Market Sharing Cat" will pop up at 11 locations across the territory from 22 January to 3 July 2018. Come catch it!
